- Upon approval of your application, only the items represented on your application can be presented for sale
- Include photos on an 8 1/2 x 11 sheet(s) of paper
- Photos will not be returned (copies are acceptable)
- All booths are required to have three walls
- Applicant must handcraft all items. As a general rule the crafter/applicant must handcraft at least 70% of each item. There are no resale items allowed
- The applicant/crafter is expected to be present in their booth
- Circle your booth preference on the application
- Returning crafters receive first placement; new crafter placements are based on the return date of the application
