

Mandatory Entry Deadline
Market Swine, Market Sheep, Market Goats
Friday, June 6, 2014
8:00 a.m. - 4:00 p.m.



- ✓ **All exhibitors are required to register their market animal by 4:00 p.m., Friday, June 6th.** Exhibitors may register their market goats, sheep and swine at the Fair Administration Office, Monday through Friday from 8 a.m. to 4 p.m., **beginning May 19th. The Fair Administration Office will have extended hours on Tuesday, June 3rd from 8 a.m. to 7 p.m.** The absolute deadline for market goat, sheep and swine registration is **4:00 p.m., Friday, June 6th.**
An exhibitor can register in person or it can be done by the club leader/chapter advisor for the group. Individual parents, grandparents, siblings, friends, etc., cannot bring in someone else's paperwork. It either has to be done as an individual exhibitor in person or as a group by the signing leader and/or advisor. **There are no excuses for not getting paperwork in on time.**
- ✓ **All exhibitors must present a Bill of Sale.**
The exhibitor should request a Bill of Sale from the person who sold them their animal.
If an exhibitor bred their own animal they must present a letter so stating.
- ✓ **All exhibitors must complete a blue entry form. Both sides must be completed, including a parent's signature and a contact e-mail address.**
There are separate entry forms for FFA and for 4-H/Grange exhibitors.
Independent exhibitors that are 9-13 years of age on the first day of the Fair should complete a 4-H/Grange entry form. Independent exhibitors that are 14-19 years of age on the first day of the Fair should complete a FFA entry form.
- ✓ **Entry fees are due with the entry form.**
- ✓ **To participate in Showmanship mark the appropriate Showmanship Class.**
- ✓ **All exhibitors must present a photograph of themselves with their market animal.**
Photographs must accompany all other paperwork. Emailed photographs will **not** be accepted.
- ✓ **All exhibitors must sign an Exhibitor Code of Practice for Participation in the Nevada County Fair.**
- ✓ **All market sheep and goats require individual scrapie identification and must be included on the entry form.**
Scrapie tags (or tattoo) to be in the right ear on June 6th and stay in place through the Fair.
- ✓ **Swine exhibitors must complete and submit an ear notch diagram.**
- ✓ **Independent exhibitors ~ it is strongly recommended that you provide evidence of general liability insurance in the amount of \$1,000,000 by providing your insurance carrier's name and your policy number.**
Liability insurance can be obtained through California Fair Services Authority's (CFSA) Special Events Program at a cost of \$35.00. Fair staff is available to assist in procuring CFSA insurance.
