Rules

- Entry forms must be received by Friday, November 18 by 4:00 pm.
- Entries must be delivered on Tuesday, November 22 between 8 am to 5 pm. Deliver to Ponderosa Hall.
- Entries must be picked up Monday, November 28, from 8 am to 5 pm.
- Entries are limited to one per category.
- Entry fee \$2. (Exhibitor receives 2 free passes to the Country Christmas Faire when the entry is delivered.)
- The house can be traditional or non-traditional.
- The size of the house and foundation shall not exceed 18" x 18" x 18".
- The house must come on a firm display board, preferably made of wood. No cardboard display boards are allowed.
- No usage of cardboard or hot glue allowed in construction of the house. No cardboard houses will be allowed.
- The house to be made from gingerbread. Usage of graham crackers or kits will be allowed only for children's classes ages 8 & under and special needs categories.
- All decoration must be edible (no artificial display materials), with the exception of the base/foundation and lighting. Candies must be unwrapped.
- Judging will be based on overall appearance, originality and craftsmanship.
- The house must have been made within the current year.
