Wednesday, August 8 (Division 991 Class 1)

"Summer Salads"

It could be fruit, potato, vegetable, pasta or any other summer salad. Judging will be based on 70% taste and 30% appearance. Bring a sufficient amount to be judged and shared.

Thursday, August 9 (Division 991 Class 2)

"My Best Dish"

Do you have a dish you are known for or one you are always asked to bring to a gathering? Create your signature dish for this contest. Judging will be based on 60% taste, 20% appearance and 20% originality. Bring a sufficient amount to be judged and shared.

Friday, August 10 (Division 991 Class 3)

"A Bushel Of Salsa" or Pico de Gallo

CELEBRATING 30 YEARS!

Create a salsa or Pico de Gallo - mild, medium or hot. May be fresh or canned. Tortilla chips provided by the judges. Bring a sufficient amount to be judged and shared.

Saturday, August 11 (Division 991 Class 4)

"Building Brownies"

Bake a pan of brownies, either from scratch or by building upon a box mix, adding your unique touch for the best brownie ever. Bring a sufficient amount to be judged and shared. We recommend no less than the equivalent of a 9 x 9 pan. The brownies may be displayed on a disposable plate or in the pan you baked them in. Judging will be based on 70% taste and 30% appearance.

Sunday, August 12 (Division 991 Class 5)

"Your Favorite Pie"

Bake a fruit, berry, sweet potato, candy bar, custard or any other type of pie. Box or prepared mixes, including commercially prepared pie crust, are NOT allowed. Judging based on 70% taste and 30% appearance. Please bring the whole pie as your entry.



LOCAL RULES

3 WAYS TO SUBMIT ENTRIES:

1. Online at NevadaCountyFair.com through July 23
 2. Pick up a contest form at the Fair Office. Complete and submit along with the \$2 entry fee by July 23 at 4 pm
 3. If entering after July 23, get a form from the Fair Office, and bring the completed form and your food entry to the Special Events Tent on the day of the contest. Entering after July 23 does not include free admission to the Fair, however the \$2 entry fee is waived.
- Limit one entry per exhibitor per contest
 - Limited to Nevada County residents 16 and older
 - Judged by a panel of local judges
 - Receiving is at the Special Events Tent - no later than 5:45 pm day of contest

ADDITIONAL INFORMATION

- Your Ultimate Food Contest early entry (by July 23) entitles you to free admission to the Fair on that contest day. A ticket will be emailed to you
- Refrigeration for entries available in the Special Events Tent on a first-come, first-served basis
- Box or prepared mixes, including commercially prepared pie crust dough, are NOT allowed for any entry except the Building Brownie Contest
